The document will be picked by a representative of the bidder from the NSSF Procurement & Disposal Unit. No liability will be accepted for loss or late delivery.

All bids must be accompanied by a bid security of **UGX 2,000,000 (Uganda shillings; Two million only)**. Late bids shall be rejected.
