- 3. Bidding will be conducted in accordance with the open bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 7(a) from 8:00 am to 5:00 pm.
- 5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 7(b) and upon payment of a non-refundable fee of UGX 100,000. The method of payment will be by Bank to National Social Security Fund Account Number 9030005950790 at STANBIC BANK UGANDA LTD. The bidders shall then submit a deposit slip to the NSSF Cashier on 14th Floor Southern Wing, Worker's House or email the receipt to anasuru@nssfug.org copy\_procurement@nssfug.org. The bidder shall be given an e-receipt on confirmation that funds have been transmitted into the specified account. The soft copy document will then be sent to the bidders or their representative (s) from NSSF Procurement and Disposal Unit.
- 6. Bids must be delivered to the address below at 7(c) at or before 15<sup>th</sup> January 2025. All bids must be accompanied by a bid security of UGX 5,000,000. Bid securities must be valid until 31<sup>ST</sup> July 2025. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 7(d) at 12:30 pm on 15<sup>th</sup> January 2025
